- 3) All refunds will be processed after the eEANS2021 Congress.
- 4) Administration Fee for name change/invoice address change/further changes is EUR 20 incl VAT.
- 5) The Organiser retains the right for any changes deemed necessary.



PAYMENT TERMS

- 1) Booked registration fees are binding and must be paid in advance.
- 2) Payments can be done via bank transfer or credit card. Any bank charges will be charged to the payer.
- 3) Registration fees depend on the date your payment is received and will be adjusted accordingly, if the payment is not received by the relevant deadline.

FORCE MAJEURE
